DIRECTIONS FOR USE

1. Determine the water volume (acre-feet or cubic meters) as follows:

$$\frac{\text{Length (ft)} \times \text{Width (ft)} \times \text{Average Depth (ft)}}{43,560} = \text{Acre-Feet}$$

or

$$\text{Length (m)} \times \text{Width (m)} \times \text{Average Depth (m)} = \text{Cubic Meters}$$

Note: One Acre-Foot = 325,000 gallons = 1,234 cubic meters

2. Use 0.25 gallons (0.95 L) of this product for each acre-foot (1,234 m³) of water as determined by using the formula above (see step 1). Pour from the container near shoreline into water. Complete, even dispersion of this product should occur within hours after treatment, depending upon water movement. Add additional amounts of this product as needed to maintain desired coloration effect following dilution or water exchange.

WATER USE RESTRICTIONS

- Allow several hours for this product to disperse before swimming, irrigation, or fishing.
- Do not apply this product directly to drinking water.
- When used at the recommended dosage rate, treated water will not stain exposed surfaces.
- When used at the recommended dosage rate, treated water will not harm fish, waterfowl, pets or wildlife.
- Chlorinated water will cause fading, requiring higher dosages or more frequent treatments.

PRECAUTIONARY STATEMENTS

CAUTION. Contains Acid Blue 9 Dye. Concentrated product may cause eye or skin irritation. Do not get in eyes, on skin or on clothing. Wear safety glasses or goggles and rubber gloves when handling. Do not taste or swallow. Wash hands thoroughly with soap and water after use. Remove and wash contaminated clothing before reuse. Do not mix with any other chemical. Concentrated product can stain fabric and other porous surfaces. Avoid direct contact with these materials.

STORAGE AND DISPOSAL

Keep this product dry in its tightly closed container when not in use. Store in a cool, dry, well-ventilated area. Keep from freezing. Do not reuse empty container. Rinse empty container thoroughly with water, then offer for recycling or dispose in accordance with state and local regulations. In case of spill, wash down with water and flush into sewer system.
